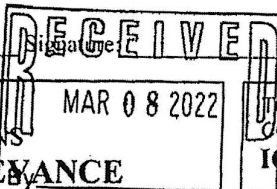

If we are allowed 2 hours per day out of our cell, and kept in our cell by ourselves away from other prisoners for 22+ hours per day, then that is the textbook definition of Solitary confinement. Furthermore, my IGP was about mental health and constitutional rights, which were completely ignored in the response.
